

# Image in Focus: Baby boomers' boom?

# **Summary of chart**

The aging US population is driving a sharp increase in healthcare demand. By 2030, more than 20% of Americans will be 65 or older – an age group with the highest per capita use of healthcare services. This demographic shift is fuelling strong demand for healthcare real estate, with all sectors poised to benefit from the growing, needs-based demand associated with an aging population.

# How does this link to the positioning of the Curate Momentum Flexible Property Fund?

The Curate Momentum Flexible Property Fund is exposed to this theme through being overweight Ventas (US senior housing and medical offices), CareTrust REIT (US skilled nursing and UK care homes) and Chartwell Retirement Residences (Canadian senior housing).

- ✓ The 80+ age group is projected to grow at a 4.5% compound annual growth rate (CAGR) through 2030, compared to 1.7% growth over the 14 years before 2024
- ✓ The aging US population particularly the Baby Boomer generation is driving a significant increase in demand for healthcare real estate, especially senior housing options
- The Curate Momentum Flexible Property Fund is well-positioned to benefit from this long-term growth trend through its holdings in Ventas, CareTrust and Chartwell Retirement Residences
